Board of Trustees

- The AMSA Board of Trustees is the organized group of volunteers who, collectively, are legally and morally accountable to the community for the success, vitality, and effectiveness of AMSA.
- The role of the BoT is governance it encompasses legal responsibilities, general oversight, planning and policymaking, and meeting fiduciary requirements.

Board of Trustees

- A charter school Board of Trustees is similar but different than a school committee
 - Reports directly to DESE at the state level, not to an individual municipality
 - Still operates according to Open Meeting Law requirements
- A charter school Board of Trustees is the primary body responsible for school's finances
 - School committees review budgets and spending but overall finances roll up into town finances
 - Charter schools have no opportunity to seek budget overrides
 - Charter schools are responsible for paying for their own facilities, they are not provided or maintained by the town
- A charter school Board of Trustees has an extra layer of accountability
 - Must pass annual audit by outside audit firm
 - Must create an Accountability Plan indicating how it intends to meet its charter obligations
 - Must report annually to DESE on progress toward its Accountability Plan

BoT Composition

- Comprised of 7- 15 members that volunteer to oversee the School's operation and function. The BoT is governed by a formal set of Bylaws and operates according to various MA statutes and regulations. Members are elected to the Board by existing membership for a term of 3 years.
- Current BoT Make-Up: 13 trustees at large; 1 faculty representative and 1 parent representative.
- There are four Standing Committees: Finance & Audit, Governance, Education, and Fundraising & Development.
- In addition, there are a number of task forces working on special areas of interest, which include, or have included: Facilities, Recruitment, Climate/Surveys, Regional Issues and Special Education



BoT Role & Function

- Ensuring Successful Charter Renewal
- Setting and overseeing the School's governing policies (Governing Policies are different from School Policies)
 - i.e. Governing Policy School must have a dress code. School Policy Setting the specific dress code
- Hiring and evaluating the School's Leader (Executive Director)
- Ensuring the school's curriculum meets educational standards
- Approving and monitoring the School's annual/capital budgets
- Conducting regular and routine public meetings where governance issues are discussed
- Discussing, Voting and Taking Actions necessary to ensure successful School operation and growth

BoT Role & Function - con't

- Ensuring independent auditors audit the School's financials annually
- Ensuring the Accountability Plan is approved by DESE annually and the Annual Report is submitted to DESE to report progress against the Accountability Plan
- Seeking approval of Charter amendments, as needed

- Represents the parent community voice to the Board as the primary liaison between the BoT and parents
- Communicates regularly with parents on the activities of the BoT at PTO meetings
- Provides parents an understanding of BoT role & responsibilities
- Nominated by PTO Board and elected by BoT to serve a oneyear term
